ENTRY INFORMATION:

These rules apply to candidates for Region and District Lion of the Year, Lioness of the Year and LEO of the Year. Any Lion, Lioness or LEO Club of District 4-C5 may enter the District Lion of the Year competition. *This individual need not be Club Lion of the Year.*

NOMINATION: Summarized score sheet and a **one page (Times New Roman, Size 12 font)** brief resume. The nomination must be in the hands of the Cabinet Secretary by April 3, 2018, so it can be screened/voted upon by the Executive Cabinet. NOTE: Summarized score sheet available on District website. Resume requirements are on next page.

OFFICIAL POINT SYSTEM: Judging will be based on a point system as follows. Scoring by the Club President and the Board of Directors must be attested.

1. **PARTICIPATION:** A Lion/Lioness/LEO who participates in all Club activities, shall earn, each activity10 Points
2. **NEW MEMBER:** New members brought into Lions during the contest year,
.....each.....20 Points.....maximum.....100 Points
3. **ATTENDANCE:** For each Club Board meeting attendance
.....each.....5 Points.....maximum..... 60 Points
Maintain 100% attendance during the contest year.maximum..... 125 Points
For each Zone, Cabinet Meeting attended 10 Points
USA/Canada Forum or International, MD-4 or District Conventioneach 20 Points
4. **PROJECTS:** Promotion of Club project or fundraiser as chair each 25 Points
as committee member, each 10 Points
5. **OTHER CLUB ACTIVITIES:** Each visitation, social function, or other club activities attended,
.....each.....5 Points.....maximum..... 150 Points
6. **LIONISM:** Personally exemplifies Lionism 25 Points

Scoring by the Club President and the Board of Directors must be attested. Summation of points accumulated must be signed by the President and the members of the Board.

RESUME:

A complete one page resume of the Lions candidate for the “District Lion of the Year” must signed by the Club President and be in the hands of the Cabinet Secretary by **April 3, 2018**. The resume is for the current year.

JUDGING:

1. The points scored and the description in the RESUME will be used with equal weight as a basis of judgment.
2. The panel of judges will be appointed by the District Governor.
3. The panel of judges will select three semi-finalists from all RESUMES received.
4. The District Governor will select the “Lion, Lioness and LEO of the Year.”

AWARDS:

There will be a Lion of the Year selected for each Region. One individual will be named the District Lion of the Year. There will be one Lioness and LEO Award as the District winner. Award presentation will be made at the District Convention.

The District Governor, Vice-District Governors, or their families are not eligible for this award.
